A) Registration for Current* NPPA Pharmacy or GPO Members (to July 8)	\$250.00

B) Registration-Only, Non-Members* (to July 8)	\$385.00
*Add a New Annual NPPA Full Membership here above, to qualify for the lower Member rate (\$10 less with Registration & New Membership, compared to Non-Member Registration alone).

Discounts Available on Reg Fees ("Comp Codes")

The Following Discounts (or "Comp Codes"), may be applied to your Registration Fee. **To enter a "Comp Code":** choose the button at the top right of the Payment Information Page, during the Registration process.

- 1) When Paid in Full by June 10, you may take \$25 off any of the Registration options, with Comp Code "EARLY-\$25".
- 2) The 2nd Attendee to Register from a Single Facility Address gets \$10.00 off the 2nd Attendee Registration Fee Only. Contact NPPA to confirm & get code.
- **3) Participating GPO Companies** are entitled to discounts for their company executives, based on their GPO participation agreement & the total of their GPO Member-Attendees at last year's NPPA Conference. For details, check with your company's main contact for the Conference, or NPPA directly.

Purchase Orders/Invoices & Outstanding Payments

Requesting a Purchase Order (PO)/Invoice for Attendee Registration Fees, implies intent to pay in full. Outstanding Registrations by Invoice/PO which are not paid by July 8, will owe the difference of the later pricing (an additional \$50 to all registration fees).

All PO's submitted before July 8 must include the deadline & increased rate when paid after that date. After July 5, Purchase Orders will no longer be accepted.

Outstanding Payments by Check (on PO or otherwise), must be received at NPPA no later than August 14, since NPPA will no longer be in the office (on way to Las Vegas).

Outstanding Payments by Credit Card may be applied to your onsite registration (through the link in your confirmation email), no later than Saturday August 17 (2 days before show start).

If you need to pay your Outstanding Invoice after these dates (onsite), you must either pay by Credit Card or with a Facility/Company Check only (no personal checks).

Registration Deadline - August 17

After the final August 17 deadline, registrations will no longer be accepted, and Onsite Registrations will not be available. If you have extenuating circumstances that prevent you from registering before August 17, you must first contact NPPA by Wednesday August 14 to get approval (at which point, an additional \$20 Onsite Administrative Fee may be due on top your applicable Registration Fee).

If you are already registered but just have not yet paid your Outstanding Invoice/PO due, see the first section above on "Outstanding Payments."

NPPA Offices Closed After August 14

Note: the NPPA offices will be closed after August 14, so do not send Check Payments by mail to our office for receipt after that date (nor important faxes).

All registration fees paid in full that are cancelled by June 8, will be refunded 100%. Cancellations between June 9 through July 17, will receive a 50% refund on their registration fees. There will be no refunds after July 17.
